

LEA Plan for Safe Return to In-Person Instruction and Continuity of Services

Section 2001(i)(1) of the ARP Act requires each local educational agency (LEA) that receives ARP ESSER funds to develop and make publicly available on the LEA's website, no later than 30 days after receiving ARP ESSER funds, a plan for Safe Return to In-Person Instruction and Continuity of Services. In New Mexico, districts and state-chartered charter schools are LEAs.

This is a federal requirement and is not the same as the past state requirement for LEAs to submit Reentry Plans.

Pursuant to ARP requirements, LEAs must post on their website a fully compliant Plan for Safe Return to In-person Instruction and Continuity of Services by **December 24, 2021**.

Universal and correct wearing of masks	Y	Masks are to be always worn indoors, except when eating or drinking in designate areas. Masks are to be two play and worn appropriately

		over the nose and the mouth. Buffs, bandanas, neck gaiters, and face shields without a mask are not acceptable forms of masking at school. Additionally, masks with exhalation valves are not acceptable forms of protection.
Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding)	Y	Cohorting remains in place due to the nature of the self-contained classroom arrangement. There are two classes that share a large space and move from one section of the classroom to the other daily. These two classes share two teachers and eat lunch together.
Handwashing and respiratory etiquette	Y	Students are taught and reminded to wash hands using soap and warm water. Students are also taught and reminded to request a mask break how to handle the break accordingly. Mask breaks are encouraged when outdoors or working independently.
Cleaning and maintaining healthy facilities, including improving ventilation	Y	Cleaning and Disinfecting occur throughout the school day. Teachers, educational assistants, the administrative team, and a cleaning crew work to maintain a clean and healthy environment.

RRVCS strives to remain open by following the guidance of the Policies in place, the New Mexico Public Education Department, and the New Mexico Department of Health. We work with families to provide supports for students to attend school in a safe and healthy manner.	
How will the LEA address Students':	
Academic Needs?	The school is purchasing curriculum that will support our mission statement while supporting students in their learning journey. We are a Core Knowledge School (E.D. Hirsch) which is a comprehensive, sequence and knowledge based, content-rich curriculum. Recently added to grades K-3 is Core Knowledge Language Arts used to will support learners both traditionally (books and skills review) and digitally. There are plans to purchase grades 4-6 soon. Additionally, MidSchMath and iReady math are used in grades K-8 to assess, progress monitor, and teach. These programs have supported students to make quicker gains while remaining engaged and accelerating learning.
Social, Emotional and Mental Health Needs?	RRVCS utilizes the services offered through Taos Behavioral Health. Counselors and support staff are available 2-3 times weekly. Students receive supports in the classroom, at recess, lunch, and during small group/individual settings.
Other Needs (which may include student health and food services)?	RRVCS is a Community Eligibility School. All students receive free breakfast, lunch, and snack.
How will the LEA address Staff:	
Social, Emotional and Mental Health Needs?	RRVCS has a supportive governance council, administrative team, and colleagues. The staff can access supports through Taos Behavioral Health, the school administrator, and the governance council.

3. During the period of the ARP ESSER award established in section 2001(a) of the ARP Act, an LEA must
 - a. regularly, but no less frequently than every six months (taking into consideration the timing of significant changes to CDC guidance on reopening schools), review and, as appropriate, revise its plan for the safe return to in-person instruction and continuity of services.
 - b. In determining whether revisions are necessary, and in making any revisions, the LEA must seek public input and take such input into account.

 - a. In an understandable and uniform format;

- b. To the extent practicable, written in a language that parents can understand or, if it is not practicable to provide written translations to a parent with limited English proficiency, be orally translated for such parent; and
- c. Upon request by a parent who is an individual with a disability as defined by the ADA, provided in an alternative format accessible to that parent.
